- The office accepts checks and money orders. (No Fee)
- The office accepts bank cards and credit cards with convenience fees added to payments.

- No fee for Bank Draft payments; forms are available on-line or in the office.

For bank/credit card payments of \$85.00 or less, a \$2.50 fee will be charged by BCA.

For bank/credit card payments of \$85.01 or more, a 2.95% fee will be fee will be charged by BCA.

For E-checks payments, a \$1.45 fee will be charged by BCA

You will see (2) entries on your financial institution statement when paying with bank/credit card or e-check (ACH). The first charge will be the water payment from MacBee and the second charge will be the convenience fee charge from BCA (the processing company)

Bills are mailed on or about the 25th of each month and are DUE UPON RECEIPT. Payments are considered late if received after the 15th of the following month. There is a \$25.00 penalty assessed on payments received after the 15th of each month.
